## Memorandum of Understanding

This Memorandum of Understanding (the "MoU") is entered into on the 12<sup>th</sup> June, 2015 between **Department of Women and Child Development, Government of Maharashtra** having its office address at 3<sup>rd</sup> Floor, New Administrative Building, Opposite Mantralaya, Mumbai (hereinafter referred to as "DWCD") and **iCare Learning Private Limited** having its Registered Office at The Capital, # 406, A Wing, Bandra Kurla Complex, Bandra East, Mumbai, Maharashtra 400051, India (herein after referred to as iCare) and henceforth collectively both are referred to as "parties" to this MoU.

WHEREAS, Department of Women and Child Development, Government of Maharashtra is the nodal department of Government which governs the implementation of schemes for welfare of women and children with specific focus on their growth, development and protection.

WHEREAS, iCare is a Company incorporated as a Private Limited Company registered under the Indian Companies Act with an aim to conduct skills, knowledge and behaviour based training, assessment and certification for the informal service providers (like chauffeurs/drivers, elder care givers, baby care givers, food court assistants and more) on a large scale across India. Further to provide the trainees a platform to get employed by individual and institutional employers.

This MoU is being entered into for collaboration on Corporate Social Responsibility (CSR) projects in the areas of skill development, entrepreneurship development and women empowerment in Maharashtra.

Now in consideration of the premises the parties hereby agree as follows:

- 1. The objective of the MoU is to impart training / skill development to women in Maharashtra, thereby ensuring socio-economic upliftment of beneficiaries.
- 2. iCare shall conduct training programs for the beneficiaries, leveraging its globally benchmarked content and delivery methodology. iCare will deploy its eLearning and blended learning platform
- 3. iCare will conduct the RPL (recognition of prior learning) of the candidates to evaluate, screen and subsequently counsel them to take the appropriate training program. Some of these programs may be customised for specific informal trades (e.g. driving, care giving etc.).
- iCare through its partners will identify employment opportunities for the candidates who have successfully completed the skilling program. However at no point of time does iCare guarantee employment temporary or permanent to the trained candidates.
- 5. DWCD shall support iCare and its partners in identification and mobilisation of candidates to undertake the Skilling/Training
- DWCD shall, as far as possible, facilitate access to training centres and other infrastructure and staff support to implement the skilling projects in the geographies where ever these programs are being implemented
- 7. DWCD will not provide any direct financial support, but the frontline staff under DWCD shall support in implementation of the project.
- 8. The representatives of both the parties shall specially monitor the progress of the initiatives undertaken under this MoU.

It is hereby expressly made clear that the intention of the parties is not to create binding agreement between the parties and no party shall have right to file claim against other party. The parties understand that neither this MoU gives any right to any party, nor does it creates a partnership, joint collaboration or employment is created as a result of this MoU. This MoU is not intended to create legally binding obligations on either Party. Except as expressly provided by this MoU, no Party will be liable for or bound by any representations, acts or omissions whatsoever of the other party.

This MOU will come into effect on date of signature by all partners and will end after 5 years from the date of signing of this agreement.

This MOU may be varied at any time by mutual agreement of the parties in writing. It shall be reviewed one month before the end of contract date or at a time mutually agreed by the parties for possible renewal.

Each Party will bear all of its own expenses necessary to meet its duties and obligations under this MoU. Neither party can create or cause to create any charge against the other party as per this MoU.
